塞浦路斯移民项目 CITIZENSHIP & PERMANENT RESIDENCE



PERMANENT RESIDENCY 永久居留权

- 1. Permanent 一步到位永居身份
- 2. Fast (within 2 months from application) 快速审理 (递交申请日起2个月)
- 3. No residency requirement 没有居住要求
- 4. No language requirement 没有语言要求
- 5. Couple, kids up the age of 25, and parents of the couple 投资人、配偶、双方的父母、25周岁以下子女均可申请,一家三代

Criteria 投资标准

- 1. 300,000 euro in property investment 30万欧元投资购房
- €30.000 deposit in applicant's Cyprus account for at least three years. 主申请人在塞浦路斯银行开立账户, 定存3万欧元三年期
- 3. Proof of annual income EUR 30.000 plus EUR 5000 per dependent person, and 8000 per parent 年收入证明 3万欧元基数,附加每人5000欧(配偶、子女),每位父母申请人8000欧
- 4. Clean Criminal Record 无犯罪记录证明
- 5. The applicants should visit Cyprus at least once every two years. 申请人需至少每两年登陆一次塞浦路斯

Passport Program 护照项目

1. The Cyprus Government enables foreign investors to obtain Cyprus (EU) citizenship through naturalization.

塞浦路斯政府允许外国投资人以投资方式归化入籍成为**塞浦路斯公民**(也即欧盟公民)

2. The program applies to the immediate family of the applicant i.e. the spouse and the children up to the age of 28 if full time university students

此项目适用于申请人的直接亲属,包括配偶及不超过28周岁全日制在读的子女

- 3. Fast track procedure: Approval will be issued within about 3 months **快速审理程序-申请递 交之日起三个月内**获签
- 4. New program is more affordable than ever 新项目以更少的投资金额要求获得更大的吸引力
- 5. This is an investment, NOT a donation 这是一项投资, <u>而非捐赠</u>!

INVESTMENT OPTIONS FOR CITIZENSHIP

公民项目投资要求

As of 14/09/2016: There is a change in the amount needed 自2016年9月14日起, 政策在金额的要求上做了更有利的调整:

- 1. € 2.0 million (plus vat) –Investment in a single Residence 投资200万欧元(附加增值税) (之前是250万欧元)购买一处单一住宅 The residence must be retained by the investors 须保留持有
- € 2.0 million (plus vat) Multiple properties investment portfolio
 投资200万欧元(附加增值税) (之前是250万欧元)投资多套房地产组合
 - a. A primary residence of a minimum value € 500,000. The residence must be retained by the investors.
 其中,需有一处价值不低于50万欧元的房产作为住宅,且须保留持有
 - b. The remaining € 1.5 million can be invested in other properties, including residential and plots which may be resold after 3 years. 另外150万欧元购买其他房地产,包括住宅物业和土地,且三年以后可出售

INVESTMENT OPTIONS FOR CITIZENSHIP 公民项目投资要求

OPTION 3, 4, 5方案二

- A. 500,000 Euro in residency, which should be retained 50万欧元自住房
- B. Plus 2 million Euro investment in **combination** of investment, which may include:

- Special government bonds of the Republic of Cyprus (not exceed 500.000 Euro) 塞浦路斯政府债券(最多50万欧元)
- Alternative investment fund




